Expanding Access to High-Quality Early Care and Learning Opportunities

An abundance of research shows that high-quality early learning results in tangible learning benefits for our youngest students, leading to long-term educational success. Likewise, self-sufficient, thriving families are economically sustained by parents' ability to work and earn a living, free from worry about safe and nurturing care for their young children. Yet here in Colorado, the past decade has seen a steady decline in the availability of affordable, quality childcare. And amidst the COVID-19 pandemic, the problem has only been exacerbated. The problem is particularly acute for parents experiencing poverty, whose ability to support their families is hindered not only by extremely limited childcare options but also costs far beyond their financial reach. We believe that equitable access to early learning and development opportunities is integral to the futures of all families in Colorado, as well as the economic vitality of the entire state. We join with educators and

concerned citizens throughout the state in supporting efforts to expand preschool to all four-year-olds

in Colorado who want it and increase access to culturally and linguistically proficient licensed child care to infants, toddlers, and three-year-olds. To achieve these goals, policymakers must focus on increasing the supply of licensed family child care homes by continuing to implement the recommendations in the Senate Bill 063 Infant and Family Child Care Strategic Action Plan.

Promoting Positive Maternal and Infant Health Outcomes

Colorado currently lacks the infrastructure needed for all families to thrive during the perinatal, birthing, and postpartum periods. This is especially true for families of color, Indigenous families, undocumented families, and people who are low-income. The solution to these issues necessitates a multi-pronged approach. Much like the Momnibus federal bill package, Colorado will see its first package of bills necessary to make perinatal care more effective and equitable. This package of maternity care bills will address perinatal disparities and will create a multi-year state policy platform supporting birth justice with a human rights framework. This will create a long-term legislative opportunity to implement a statewide birth equity agenda. This will include a Human Rights component, and a Data, Equity component, as well as the Direct Entry Midwifery Sunset. *Continued on next page*.

Continued from previous page. Midwives are medical providers with expertise in the perinatal period and childbirth. In Colorado.

they currently assist with childbirth in the home and are the preferred choice of care for many families. Midwives have specific cultural ties to communities like Black, Indigenous, and other People of Color. The midwifery model of care provides optimal birth outcomes for lowrisk families. In Colorado, professional credentials are "sunsetted" every three years,

rendering them invalid without reauthorization

from the legislature. The direct entry model of midwifery requires a national credential through the North American Registry of Midwives, certifying them as a professional midwife and allowing them to obtain licensure with the state. This credential is set to sunset in 2021, and therefore must be reauthorized.

Strengthening Colorado Families Amidst the COVID-19 Pandemic

At Clayton, we know that when parents are healthy financially, emotionally, mentally, and physically, their children thrive. Too many Colorado families face food insecurity, unstable or unsafe housing, barriers to basic healthcare, and racism – exposing parents and children to toxic levels of stress. Those issues have been exacerbated by the COVID-19 pandemic. Coping with such critical survival issues repeatedly, over long periods of time causes profound and lasting implications for even the youngest children, stalling healthy development and their capacity to learn and succeed. We recognize the inherent societal value of healthy families as both a moral and an economic imperative for a sustainable and prosperous future for Colorado. This is why, alongside our partners and families, we are excited to implement an accessible and affordable paid family and medical leave program, expand the Earned Income Tax Credit for families, increase access to health insurance and support housing assistance relief for families.
